उपरोक्त विषयान्तर्गत प्रासंगिक पत्र द्वारा जॉब कार्ड नवीनीकरण (Using e-KYC feature) अभियान के संबंध में निर्देश प्रदान किये गये है। ग्रामीण विकास मंत्रालय, भारत सरकार द्वारा जारी दिशा निर्देश में जॉब कार्ड नवीनीकरण के लिए एनएमएमएस ऐप में एक नया ई—केवाईसी फीचर शुरू किया गया है, जिसके माध्यम से नामित किये गये पायलट जिलों (कोटा एवं झुंझुनू)में जॉबकार्डस का नवीनीकरण एक अभियान चलाया जाकर 30.09.2025 तक पूर्ण किया जाना है। राज्य सरकार द्वारा 17 सितम्बर 2025 से चलाये जा रहे ग्रामीण सेवा शिविरों में सभी जिलों में जॉब कार्ड नवीनीकरण (Using e-KYC feature) की प्रकिया पूर्ण किया जाना है। अतः इस संबंध में ग्रामीण विकास मंत्रालय, भारत सरकार द्वारा प्रदत्त निर्देशानुसार कार्यवाही किया जाना सुनिश्चित करावें।

Subject: Job Card Verification and Renewal - reg.

Madam/Sir,

As you are aware, Para 3 of Schedule II of the Mahatma Gandhi NREGA states that "the job card, once issued, shall remain valid for at least five years, after which it may be renewed following due verification."

- 2. In this context, it has been decided to take up a campaign "Job Card Renewal with e-KYC Feature" across all the States/UTs. The campaign will be initially taken up in 2 districts of each State and 1 district of each UT and North-Eastern State, based on identification done in consultation with the States/UTs. List of pilot districts is attached herewith. It is requested to complete the campaign in these districts by 30th September 2025. This initiative is aimed at ensuring timely renewal of job cards and streamlining the process on a regular basis.
- 3. To facilitate this exercise, a new e-KYC feature has been introduced in the NMMS App for undertaking job card renewal. This will not only ensure timely completion of the campaign but also help in improving efficiency and transparency in the renewal process.
- 4. For effective implementation of this campaign, the following strategy shall be adopted:
- (i) Training and Onboarding of Field Functionaries: A comprehensive training and onboarding plan for field-level staff shall be undertaken in parallel. A national-level virtual training for all States/UTs was completed on 04.09.2025. Thereafter, States/UTs are required to organize training for field functionaries to ensure smooth implementation.
- (ii) Phased Rollout: Upon successful implementation in the pilot districts, the job card renewal campaign shall be scaled up to all remaining districts of the States/UTs.
- (iii) Commencement of Campaign: Job card renewal through the e-KYC feature of the NMMS App will be operational in the identified pilot districts. As the e-KYC feature functions in network-enabled areas, States/UTs must identify village-wise campaign locations with adequate internet connectivity and easy accessibility for workers.

- (iv) It is expected that the eKYC will be completed in the pilot districts by 30th September. Necessary arrangements must be made during the campaign period to ensure that eKYC is completed for all workers so that no genuine worker is left out of the renewal process and the demand for employment is met as per the mandate of the act.
- (v) Coverage of All Workers: Renewal through the e-KYC feature is to be carried out for all workers registered under each job card.
- (vi) Role of Field Functionaries: As the process will be undertaken through the NMMS App, registered staff (e.g., GRS or other GP-level functionaries) may carry out job card renewal using the e-KYC feature. The program officer may authorize the GP level functionaries, as per the requirement, for the implementation of eKYC through NMMS.
- (vii) Adherence to Timelines: States/UTs are requested to ensure strict adherence to the above timelines.
- 5. This issues with the approval of the Competent Authority.
