महोदय,

उपरोक्त विषयान्तर्गत संदर्भित पत्रों के क्रम में लेख है कि माननीय प्रधानमंत्री महोदय द्वारा नरेगा योजनान्तर्गत श्रम मद भुगतान दिनांक 01.04.2015 से आधार आधारित करने के निर्देश दिये हैं। इस संबंध में भारत सरकार द्वारा आयुक्त, ईजीएस के साथ दिनांक 21.02.15 को वीडियो कॉन्फ्रेंसिंग के माध्यम से आधार सीडिंग की प्रगति को बढ़ाने के संबंध में चर्चा की गई।

चर्चा के दौरान भारत सरकार द्वारा निम्न निर्देश दिये गये:-


1. जॉब कार्डधारी नरेगा श्रमिक, जिनके UID/EID नम्बर जारी किया जा चुका है, की सीडिंग नरेगा सॉफ्ट में करवाई जावे। इस हेतु नरेगा सॉफ्ट में कार्य मांग के समय UID/EID प्रविष्टि का विकल्प उपलब्ध करवा दिया गया है। इसके अतिरिक्त राज्य सरकार द्वारा संचालित भामाशाह योजना में जिन नरेगा श्रमिकों को भामाशाह नम्बर आवंटित किया जा चुका है, का नरेगा सॉफ्ट में इन्द्राज का विकल्प दिनांक 05.03.15 तक उपलब्ध करवा दिया जावेगा। अतः इसकी प्रविष्टि भी करवाया जाना सुनिश्चित करें।
2. पंचायत समिति स्तर पर स्थापित Permanent Enrollment Centres (PEC) से सम्पर्क कर विशेष आधार रजिस्ट्रेशन कैंप का आयोजन कर जिन श्रमिकों के UID/EID नहीं हैं, के रजिस्ट्रेशन की कार्यवाही की जावे। PEC की list वैबसाईट censusindia.gov.in पर उपलब्ध है।
3. कार्य की मांग के समय यदि श्रमिक के पास UID/EID नम्बर नहीं हैं तो कार्यक्रम अधिकारी द्वारा निकट के PEC से उस श्रमिक का EID नम्बर प्राप्त करने की कार्यवाही की जावे। इस हेतु PEC पर आने-जाने का खर्चा योजनान्तर्गत प्रशासनिक मद से वहन किया जावेगा। EID नम्बर प्राप्त होने पर इसकी सीडिंग नरेगा सॉफ्ट में कार्य मांग के समय पंचायत समिति स्तर पर कराया जाना सुनिश्चित किया जावे।

4. जिला कलेक्टर द्वारा जिले के जिन क्षेत्रों में आधार रजिस्ट्रेशन कम हुआ है, का आकलन कर विशेष कैंप के माध्यम से EID नम्बर जारी करवाने की कार्यवाही की जावे।
5. ऐसे श्रमिक जिन्हें UID/EID नम्बर जारी किया जा चुका है, परन्तु नरेगा सॉफ्ट में सीडिंग नहीं की गई है, के लिए कार्यक्रम अधिकारी द्वारा ग्राम पंचायत पर कार्यरत GRS/LDC को श्रमिकों के निवास स्थान पर जाकर UID/EID नम्बर प्राप्त किये जाने हेतु निर्देशित किया जावे। साथ ही श्रमिक का जिस बैंक में खाता है, का विवरण भी प्राप्त कर UID नम्बर को सम्बन्धित बैंक में जमा करवाकर UID नम्बर का बैंक खाते के साथ linkage करवाया जावे, जिससे कि UID नम्बर की बैंक खाते के साथ mapping के लिए National Payment Corporation of India (NPCI) को भेजा जा सके।
6. नरेगा सॉफ्ट पर उपलब्ध रिपोर्ट "R1.1.6 Aadhar demographic verification status report" के अनुसार राज्य में लगभग 7 लाख UID नम्बर (Active Labour) को PO Login से verify किया जाना शेष है। इसके लिए ग्राम पंचायत स्तर पर कार्यरत GRS/LDC द्वारा physically verification करवाया जाकर नरेगा सॉफ्ट में अपडेट किये जाने की कार्यवाही की जावे।

कृपया उपरोक्तानुसार कार्यवाही सुनिश्चित करावें।

**Sub: MGNREGA on DBT platform in 300 districts from 1<sup>st</sup> April 2015**

Madam/Sir,

As you are aware that MGNREGA has been notified under DBT scheme by the Ministry of finance covering 287 districts under MGNREGA vide their letter dated 12.12.2014. In continuation to this, it has been decided that direct cash transfer takes place only on DBT platform from **01.04.2015** onwards.

2. In order to operationalise this, the following steps are to be taken by the States in these 300 districts:

- a) Concerted effort for **collection of Aadhaar numbers** of workers who are already enrolled for Aadhaar; and seeding that data in the NREGASoft database, so that it can be completed by end- March 2015.
- b) **Organization of special enrolment camps** for those workers who missed enrolling for Aadhaar. This should be done in consultation with the State Registrar for Aadhaar. The planning of the location (and the duration) of these special camps may be carefully done keeping in view the number of workers left out of enrolment, to ensure ease of access.

3. In order to achieve the above, the following is the proposed action plan:

- a) With effect from 1<sup>st</sup> April 2015, the Aadhaar or EID number (in case if, Aadhaar number is not available) of the workers shall be noted at the time of registration of demand. The facility to note these details will be made available in NREGASoft from 23<sup>rd</sup> February onwards.
- b) In case any worker has not yet got enrolled for Aadhaar, it shall be the responsibility the Block Development Officer to arrange to escort such worker to the nearest Permanent Enrolment Centre (PEC) and get the enrolment done. The cost of travel to the PEC shall be met from the administrative costs and shall not be loaded on to the worker. As soon as the enrolment is done, the BDO or the representative of the Block administration shall enter the Enrolment ID (EID) in the database.

However, the demand for work shall be honoured till the EID number is obtained.

- c) All DPCs may be requested to facilitate organizing focused enrolment camps to complete enrolments in those areas where substantial number of workers are left out of enrolment.
  - d) In order to seed the Aadhaar numbers of the workers (who already have got Aadhaar numbers) in the database, PO/ BDO of the respective Blocks shall be assigned the task of quick and accurate collection of the Aadhaar numbers by deputing the GRS or Panchayat functionary to the residence of the workers. This action needs to be driven by the District Collectors so as to reach conclusion before 31<sup>st</sup> March 2015. The daily progress in this regard may be monitored by the MGNREGA Commissioner at the State level. In order to monitor this, a village wise report is available in NREGASoft MIS Reports (**Ref: NREGASoft MIS Report R.19.1: - List of active workers without Aadhaar number**).
  - e) Further, the Aadhaar numbers of workers shall be presented in the Bank branch concerned with a request to seed in their database and placed on NPCI mapper.
4. Further, it is found that there are more than 85 lakh Aadhaar numbers which are pending cross-check by the Programme Officers in view of discrepancies found during the UIDAI's demographic authentication process. (**Ref: NREGASoft MIS Report R19.6**). A drive may be launched for checking these records and the backlog shall be fully cleared by 31<sup>st</sup> March 2015.
5. In order to monitor the implementation of the above strategy, it is proposed to have a Video-Conference with State level DBT teams **every Saturday** starting **from 21<sup>st</sup> February 2015**. It is requested that an immediate strategy session may be held with all the District Collectors in the matter for smooth implementation of the given tasks within the given time limits.

Dear Shri Subramanyam,

I invite kind attention to your DO No.M-12014/2/2010-DCTNEC dated 11.02.2015 regarding the enrolment of MNREGS job card holders under NPR for the Aadhaar numbers.

2. In this connection, I am to mention that in the 12 NPR States/UTs more than 1500 Permanent Enrolment Centres (PECs) are functioning at the Tehsil/ Block Offices, Collector's office and the office of the respective State Directorates of Census Operations. Instructions have already been issued to all the State Governments to avail the facility of these PECs for enrolment of left over population in these states. There are two sets of biometric kits alongwith manpower who are at the disposal of Tehsildar/BDOs. The beneficiaries may be either brought to the Tehsil/BDO office for enrolment or if there are a large number of beneficiaries in a village or Gram Panchayat, the biometric kits and operators can be taken for targeted enrolment. The list of such PECs in various States/UTs is available in the website: [censusindia.gov.in](http://censusindia.gov.in).

3. I would request you to kindly send instructions to all States/UTs to avail this opportunity and complete the enrolment process. In case additional arrangements are to be made, we may be intimated.

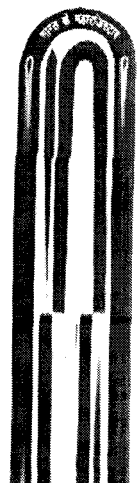
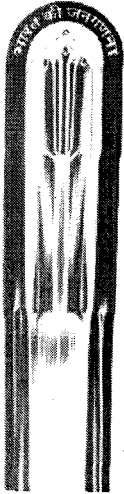

**Sub:Enrolment of MGNREGS job card holders under NPR for Aadhaar numbers – Reg.**

May kindly refer to letter No. M-12014/2/2010-DCTNEC (325218)dated 18<sup>th</sup> February, 2015 regarding the decision that direct cash transfer under MGNREGA will take place only on DBT platform from 01.04.2015.

2. In this regard, MoRD shared the action plan with all States to seed the Aadhaar number of the MGNREGA beneficiaries and enrol the MGNREGA beneficiaries who have not yet got enrolled for Aadhaar.

3. In this connection, Registrar General of India (RGI) has shared vide letter dated 17<sup>th</sup> February, 2015 that in the 12 NPR states/ Uts more than 1500 Permanent Enrolment Centres (PECs) are functioning at Tehsil/ Block Offices. Collector's Office and the office of the respective State Directorates of Census Operations.

4. In these PECs beneficiaries may either be brought for enrolment or if there are large numbers of beneficiaries in a village / GP, the biometric kits and operators can be taken for targeted enrolment. The list of such PECs in various states/ UTs is available in the website : [Censusindia.gov.in](http://Censusindia.gov.in)

5. In case any worker has not yet got enrolled for Aadhaar, it shall be the responsibility of the Block Development officer / PO (MGNREGA) to get them enrolled for Aadhaar.

**Minutes of Video Conference with States  
held on 21<sup>st</sup> February 2015**

Hon'ble PM has directed that MGNREGA payments in the 300 DBT districts should be ONLY on DBT platform from 1st April 2015. To enable this, a lot of work needs to be done on the field for seeding and verification of Aadhaar numbers for MGNREGS workers. In this regard, the Ministry held a VC on 21<sup>st</sup> February 2015 with State RD Secretaries / NREGA commissioners to discuss the plan, progress and issues related to Aadhaar seeding and verification. The following are the key discussion points from the VC:

1. The states were requested to undertake collection of Aadhaar numbers on a mission mode basis for all workers whose Aadhaar number is yet to be seeded in the database. In particular, the below points were discussed -
  - a. States were requested to undertake a concerted effort for collection of Aadhaar numbers of workers who are already enrolled for Aadhaar; and seeding that data in the NREGASoft database.
  - b. States were requested to coordinate with UIDAI and NPR for organization of special enrolment camps for those workers who missed enrolling for Aadhaar. The planning for location (and the duration) of these special camps may be carefully done keeping in view the number of workers left out of enrolment.
  - c. It was also communicated that in 300 districts under DBT, from April 1<sup>st</sup> 2015, Aadhaar number would be noted at the time of demand registration. In absence of an Aadhaar number, the portal would allow entry of Enrolment ID for the worker. If the worker has not enrolled yet, it will be the responsibility of the Block Development Officer (BDO) to escort such a worker to nearest Permanent Enrolment Center (PEC) set-up at the block level by UIDAI or NPR.
  - d. It has been observed that a large number of Aadhaar are pending for verification at PO level post rejection by AUA-ASA. The states were requested to issue instructions to the field to clear the backlog and monitor the progress of verification.
2. The meeting then progressed to review the status of Aadhaar seeding state-wise.
3. While Andhra Pradesh and Telangana have completed >90% seeding, there is some pendency for verification of records. AP and Telangana are not able to verify the Aadhaar numbers algorithmically as these records are not present in SRDH as residents opted for privacy option not sharing the UIDAI data with SRDH. States were requested to share the data for verification with MoRD so that this verification can be undertaken through SRDH / Planning Commission route.
4. The state officials from Chhattisgarh confirmed that they have initiated required action for Aadhaar seeding and verification. The state will be able to complete seeding in DBT districts before end of March 2015.
5. State of Gujarat confirmed that while there has been slow progress on Aadhaar seeding till now, it will take necessary actions to complete Aadhaar seeding by 30 April 2015. The state however emphasized that Aadhaar penetration in rural areas is low. UIDAI confirmed that Permanent Enrolment Centers are available at block level in Gujarat and special camp for

Aadhaar enrolment can be set-up in coordination with State UID nodal department (General Administration Department) and UIDAI Regional Office, Mumbai.

6. While there is no district from Bihar in 300 DBT districts, the state has initiated activity of seeding in Arwal, Sheohar and Sheikhpura districts which were part of original list of 121 districts under DBT notified by Government of India. The state government plans to complete activity of seeding by 15<sup>th</sup> March 2015.
7. The state of Haryana is already planning setting up special camps to complete Aadhaar enrolment and seeding in coordination with UIDAI. This activity will be completed by 15<sup>th</sup> March. The state has requested a report that shows beneficiary credit account for all successful transactions. NIC will fix report 8.7.1 to reflect the credit account information received from banks.
8. Himachal Pradesh was the first state in the country to move to Aadhaar based payments and barring a few exceptions, their transition has been smooth. The state has initiated process to complete seeding for the remaining workers within next 1 month. This target will be achieved for all districts except Lahul&Spiti and Kinnaur.
9. State officials from Rajasthan are actively monitoring the progress of Aadhaar seeding and have set-up weekly VCs to monitor district wise progress. Apart from that, state RD department will take help from state registrar to complete Aadhaar enrolment for those workers who missed enrolment drive through special camps. The state has also initiated drive to change bank accounts of NREGA workers from non-CBS cooperatives and RRBs to CBS enabled banks. The state has requested NIC to allow for entry of Bhamashah ID, the state government's database to aggregate resident information, in NREGASoft. NIC will work towards providing this feature in PO login.
10. The state of Jharkhand has confirmed that they will be able to complete Aadhaar seeding and clear pendency for Aadhaar verification within next 20 days.
11. Karnataka was early adopters of Aadhaar seeding but the slow progress over past 3 months has left much to be desired. The state will now start a special drive and conduct focused reviews with every district to monitor the progress.
12. Kerala has achieved >80% seeding in active worker records and plans to complete seeding before completion of deadline of 3 months. The state has requested facility to download bank-wise excel files for seeding in PO and State log-in. The state has also requested to provide INR 5 assistance for seeding of Aadhaar numbers, for which UIDAI will send details of process to be followed and sample project report to be prepared.
13. State Government of Maharashtra has initiated a drive from 15<sup>th</sup> Feb to 31<sup>st</sup> March to complete seeding. The state has prepared a comprehensive plan to address all cases such as (i) Not enrolled for Aadhaar (ii) Enrolled for Aadhaar but not received the letter (iii) Lost Aadhaar (iv) Lost Aadhaar as well as enrolment slip. The state is educating the field officials to address all these cases and complete Aadhaar seeding and verification by 31<sup>st</sup> March.
14. State of Punjab has completed more than 90% seeding and will complete the remaining Aadhaar seeding and verification by 31<sup>st</sup> March 2015.
15. States of Sikkim and Tamil Nadu have started initiated action on Aadhaar seeding post issue of advisory by the Ministry. State governments are doing regular follow-up with district officials on progress.

16. West Bengal has initiated drive to collect Aadhaar number for workers not only in districts under list of DBT districts but also in remaining districts as well. While there have been cases of workers being reluctant to provide Aadhaar number, the state is handling issues faced on ground. State would also like to avail INR 5 assistance for seeding extended by UIDAI and has requested for details of process and sample of project report.
17. For Andaman & Nicobar, there has been an issue with district code for enrolment conducted by UIDAI due to which the Aadhaar enrolment numbers are wrongly projected amongst districts. The state has started drive for Aadhaar enrolment in Nicobars, where Aadhaar enrolment has taken place.
18. Tripura has initiated action on drive for Aadhaar seeding and has called for a meeting of all district collectors. In this meeting, the state will define the strategy for Aadhaar seeding in detail.
19. The below table summarizes all action points, responsible team and timelines for the same -
