**Subject:** Clarification on providing unskilled wage component under MGNREGA.

**Reference:** Guidelines for taking up unskilled wage component under MGNREGA in construction of houses sanctioned under IAY or such other State or Central Government Scheme, issued vide letter No.-J-11017/40/2011-MGNREGA (UN), dated 30<sup>th</sup> June, 2014.

Sir/ Madam,

In accordance with the amended Schedule - I of MGNREGA, at Para 4 (1) II. (v) "Unskilled wage component in construction of houses sanctioned under the Indira Awas Yojana or such other State or Central Government Scheme" can be covered under MGNREGS in creation of an individual assets for vulnerable section (only for households in Paragraph 5 of Schedule-I, MGNREGA). Accordingly, vide the reference cited above, based on the unskilled work involved in constructing a standard house under IAY, 95 days for north-east, hilly region and 90 days in other areas of unskilled wage component has been provided under MGNREGS for each such house.

2. Since the Para 4 (D) (vii) of Schedule I of the Act provides for "production of building material required for construction works under the Act as a part of the estimate of such construction works", certain States have sought clarification whether building material required for IAY housing can be produced under MGNREGS provided as an additional assistance over and above the unskilled persondays already provided.

3. It is hereby clarified that as long as the building material is produced in accordance with the guidelines issued for production of building materials vide Ministry letter No. J-11017/26/2008-MGNREGA (UN), dated 13<sup>th</sup> January, 2014, such a facility is available over and above the unskilled persondays provided in construction of the house.

**Subject:** Amendment in revised guidelines & action plan issued on, "Construction of Individual House Hold Latrines (IHHLs) under MGNREGA for Swachh Bharat Mission".

**Reference:**

- i) Guidelines for Construction of Individual House Hold Latrines (IHHLs) under MGNREGA, issued vide Ministry letter No. **J-11017/41/2011-MGNREGA (part), dated 25<sup>th</sup> November, 2014,**
- ii) **Action Plan for Swachh Bharat Mission under MGNREGA, issued vide Ministry letter No. J-11017/41/2011-MGNREGA (part), dated 19<sup>th</sup> January, 2014,**

Madam/Sir,

As you are aware, under the Swachh Bharat Mission, construction of Individual Household toilets on a saturation mode shall be taken up in identified Gram Panchayats under MGNREGA. Accordingly, States have intimated that 31,359 GPs would be taken up under this mode for converting them into ODF. However, as of now, only 10,535 GPs have been identified.


2. When the matter was discussed in the recently concluded PRC meeting, States have expressed difficulties in maintaining the wage material ratio when construction of IHHLs is taken up on a saturation mode by the Gram Panchayats as PIA. They have also expressed difficulties in getting material for construction in time.

3. The matter was examined in the Ministry and the following have been decided:

- a) Wherever it is required, the concerned Block Panchayat or the Federation of the Self Help Groups formed under NRLM may be noted as the implementing agency.
- b) In all such cases, the overall material component including the wages of the skilled and semi-skilled workers shall not exceed forty percent at the District level.

- c) There shall be a single muster for every IHHL covering all the unskilled persondays as per the estimate issued by the PO **in favour of the beneficiary** as and when demanded by the beneficiary & will be maintained by the beneficiary.
- d) The **PIA** shall be mandated to supply construction material in advance to the beneficiary. This amount could be adjusted from the final bill due to the beneficiary.
4. Accordingly, in the guidelines & the action plan issued from the Ministry as referred above, the amendments as in Annexure-I have been issued.
5. All the State Governments are requested to convey these revised instructions to all implementing agencies and ensure that the progress in execution is improved.
