Subject: Convergence of Member of Parliament Local Area Development (MPLADS) with MGNREGA.

This is in reference to the Ministry of Statistics & Programme Implementation letter no. C/16/2009-MPLADS dated 13.01.2012 circulating instructions/guidelines on the convergence of Member of Parliament Local Area Development (MPLADS) with the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA).

2. The instructions as contained in para 3.17.1 on the convergence of MPLADS with MGNREGA in the MPLADS Guidelines have been examined in the Ministry. To bring in clarity on the instructions allowing convergence of MPLADS with MGNREGA, Ministry of Rural Development has drawn up a detailed guidelines covering issues viz. (a) selection/recommendation of activities (b) nomination of project implementing agencies (c) adherence to provisions of MGNREGA-2005 (d) sharing of project costs and (e) management and monitoring of progress of the converged activities. A copy of the Guidelines is enclosed and is being communicated to the State Government/ District Project Coordinators for compliance.

3. The Guidelines have been seen and approved by the Hon'ble Minister, Rural Development. It is, thus, requested that suitable modifications may be carried out in the MPLADS Guidelines and, accordingly, revised guidelines may be issued to all concerned with a copy to this Ministry.

**Guidelines for Convergence of Member of Parliament Local Area Development Scheme (MPLADS) with the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA)**

Fund from MPLADS can be converged with MGNREGA with the objective of creating more durable assets.

The convergence will be subject to the following conditions which have to be complied with strictly:-

1. Hon'ble MPs may recommend under MPLADS, convergence works only out of the shelf of MGNREGA projects approved by the Zilla Panchayat for the year when recommendation is being made. The work should have been sanctioned by the District Project Coordinator and be part of the approved Annual Work Plan under MGNREGA of the District.
2. The resolution of the Gram Sabha of the GP concerned accepting the recommendation of the Hon'ble MP and according its approval to use the funds from MPLADS through convergence for a MGNREGS work is necessary to sanction the convergence project.
3. The Gram Panchayat shall be nominated as the Implementing Agency by the District Project Coordinator for the convergence works under MPLADS. It shall not be permissible for line departments to take up such works. The DPC shall provide adequate technical support to the Gram Panchayat to implement the works.
4. The convergence project should comply with the non-negotiable of MGNREGA such as no machinery, no contractors etc. All provisions for proactive disclosures, includes uploading of data on NREGA website etc. will have to be complied with. The full expenditure on the convergence project will be subject to Social Audit by Gram Sabha as per the Audit of Scheme Rules, 2011 of MGNREGA.
5. The contribution from MPLADS should not be less than 25% of the total project cost. The MPLADS funds shall be used in respect of material component only (including wage of skilled and semi-skilled works.)
6. In respect of all material costs born under the project from MGNREGA funds, the Central Government will bear only upto three-fourths of the material cost under MGNREGA and the rest has to be borne by the State Government. The amount cannot be met from MPLADS funds.
7. Once a work recommended by an M.P. for MGNREGA has been accepted by the Gram Sabha, the work cannot be withdrawn.
8. Separati provision will be made in MGNREGASoft database to capture all the details of the convergence project including the break-up of the project costs, contribution from MGNAREGA & MPLADS, name of the Hon'ble M.P. etc.
9. The accounts of Expenditure will be strictly maintained separately for both MPLADS and MGNREGA with separate muster rolls. A joint plaque (stone/metal) indicating the cost involved and contribution from MPLADS/MGNREGA. Commencement, completion and inauguration and the name of the MP sponsoring the work under MPLAD Scheme/MGNREGA should be permanently erected. The work will be part of the asset of the Gram Panchayat and will be included in the MGNREGA work Register.
