- Measurement must be as per group task.
- Empanelment & engagement of women mate and their capacity building
- Ensure 100% Timely payment
- Ensure SC/ST households participation up to 100 days.
- Social Audit process to be strengthened
- Rigorous monitoring & supervision/related accountability norms to be followed.
- Training of newly elected panchayat members.
