**Subject:** Recovery against non-permissible work and deposit of recovered amount into State Employment Guarantee Funds (SEGF) under Mahatma Gandhi NREGA- redg.

Madam/Sir,


Undersigned is directed to convey that as per the existing provision of the Act, the Programme Officer(Mahatma Gandhi NREGA) is to scrutinise the annual plans on the parameters of whether the works fall under the list of permissible works, and whether the overall wage material ratio is maintained. The Programme Officer then consolidates these plans in the Block Plan and submits it to the Block Panchayat for approval. Also the items/material proposed to be procured should strictly be for the permissible works under Mahatma Gandhi NREGS.

2. This has been brought into the notice of this Ministry that in some of the states, non-permissible work(s) is being taken up under head of some other permissible work under Mahatma Gandhi NREGA.

3. The matter has been examined by this Ministry. Accordingly, it has been decided to issue an advisory as under:

*"In case any such non permissible activity has already been done under any head of permissible work under Mahatma Gandhi NREGA, state should ensure the due recovery of the expenditure, already incurred, from the concerned officials/agency, as per the due process of the state and deposit the recovered amount into State Employment Guarantee Funds (SEGF) account under intimation to this Ministry. Further, due mechanism may be put up in place to avoid recurrence of such activity."*
