उपरोक्त विषयान्तर्गत लेख है कि ग्रामीण विकास मंत्रालय, भारत सरकार द्वारा दिनांक 21.07.2014 को महात्मा गांधी राष्ट्रीय ग्रामीण रोजगार गारंटी अधिनियम 2005 की अनुसूची 1 में निम्नानुसार संशोधन किये गये हैं :-

- पैराग्राफ-4 के सबपैरा-1 (a) In the heading of item II, for the words "INDIVIDUAL ASSETS" , the words "COMMUNITY ASSETS OR INDIVIDUAL ASSETS" shall be substituted. (b) In the heading of item III, for the words "FOR NRLM", the words "INCLUDING FOR NRLM" shall be substituted;
- पैरा 4 के उपपैरा 2 में "Provided that the **District Programme Coordinator shall ensure that at least 60% of the works to be taken up in a district in terms of cost shall be for creation of productive assets directly linked to agriculture and allied activities through development of land, water and trees.**" प्रावधान जोड़ा गया है
- पैरा 20 को "For all works taken up by the **Gram Panchayats**, the cost of the material component including the wages of the skilled and semi-skilled workers shall not exceed **forty per cent at the Gram Panachayat level**. For works taken up by the **implementing agencies other than Gram Panachayats**, the **overall material component** including the wages of the skilled and semi skilled workers shall not exceed **forty percent at the district level.** " से प्रतिस्थापित किया गया है।

NOTIFICATION

New Delhi, the 21st July 2014

S.O. _____(E)_____:-In exercise of the powers conferred by sub-section (1) of section 29 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (42 of 2005) hereinafter referred to as the said Act, the Central Government, on being satisfied that it is necessary and expedient to do so, hereby makes the following further amendments in Schedule I to the said Act, namely:-

In the said Act, in the Schedule I, -

1. In Paragraph 4, in Sub paragraph (1),-
 - a. In the heading of item II, for the words "INDIVIDUAL ASSETS", the words "COMMUNITY ASSETS OR INDIVIDUAL ASSETS" shall be substituted.
 - b. In the heading of item III, for the words "FOR NRLM", the words "INCLUDING FOR NRLM" shall be substituted;
2. In Paragraph 4, in Sub-Paragraph (2), the following shall be inserted, namely:-

"Provided that the District Programme Coordinator shall ensure that at least 60% of the works to be taken up in a district in terms of cost shall be for creation of productive assets directly linked to agriculture and allied activities through development of land, water and trees.";
3. For Paragraph 20 the following shall be substituted, namely:-

"For all works taken up by the Gram Panchayats, the cost of the material component including the wages of the skilled and semi-skilled workers shall not exceed forty per cent at the Gram Panchayat level. For works taken up by the implementing agencies other than Gram Panchayats, the overall material component including the wages of the skilled and semi-skilled workers shall not exceed forty per cent at the **district level**."
