Subject: Advisory on selection of work sites and other technical inputs for execution of MGNREGS works.

Sir/Madam,

In the course of review meetings held recently, it has come to the notice of the Ministry that in some States, selection of site for MGNREGS works was not done properly, as a result of which the assets created could not achieve the intended objectives. Very often the excuse that the work site was selected by the Gram Panchayat, is cited by the officials.

2. In this regard, attention is invited to section 16 (8) of MGNREGS Act, 2005 which states that "The works taken up by a Gram Panchayat under a Scheme shall meet the required technical standards and measurements".


3. In every State, technical manpower has been deployed at Block level and District level to provide technical support to the GPs in optimal site selection (based on topographical, hydrogeological surveys and other technical parameters) and provide other inputs in the execution of works.

4. As an illustration, if a GP has identified and included a water harvesting structure in the approved shelf of work, then the technical staff deployed at the block level must provide the technical inputs required for selecting the site for such a structure. Technical data may be collected and analysed using the state of the art techniques (Topo-sheets, satellite imagery, digital elevation model to name a few).

5. In the operational guidelines, 2013 at Para 14.6 under Internal Quality Management, different technical activities like Site Selection, Survey for works and layout etc. have been mentioned, which are to be carried out by the technical staff so that the assets created meet the needed technical standards.

6. Therefore, it is of utmost importance that the sites selected for MGNREGS works are technically sound so that assets created are productive and durable which is an important objective of the Scheme.


