





**Subject: Stoppage of construction of "Boribandhs" under Mahatma Gandhi National
Rural Employment Guarantee Act (MGNREGA)-reg**

Sir/Madam

- 1. I am directed to say that this Ministry has received reports that in a few States 'Boribandhs', which are temporary structures for arresting flow of water, have been taken up under Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA).
- 2. Boribandhs are, in a way, temporary structures that get washed away with the flow of water in monsoons. As such, these are not "durable assets".
- 3. The objective of Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) is creation of durable assets. As 'Boribandhs' are not in any way durable assets, States/UTs are advised not to take up such temporary structures under MGNREGA.
- 4. This issues with the approval of Additional Secretary (RD).
