Subject: Implementation of Hon'ble Supreme Court Order dated 15.10.2015 on Aadhaar Scheme under MGNREGA-Regarding.

Sir/Madam,

I am directed to refer to the Ministry's letter of even No. dated 26th October, 2015 vide which a copy of Hon'ble Supreme Court Order dated 15.10.2015 on use of Aadhaar under Mahatma Gandhi NREGA was enclosed for information and necessary action.

2. It is observed that the State Governments have expedited the process of Aadhaar enrolment and seeding into NREGASoft. However, you are requested to confirm that the above Hon'ble Supreme Court Order is being implemented.

3. In line with the Hon'ble Supreme Court Order dated 15.10.2015, all States/UTs will have to go by the following:-

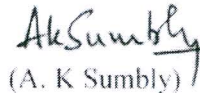
- A. Aadhaar number has not been made mandatory for the beneficiaries to get MGNREGA entitlements.
- B. Before the beneficiary gives his / her consent and share his/ her Aadhaar number to the field functionaries, the advantages of (i) Aadhaar enrolment (ii) seeding in programme & bank database and (iii) getting Aadhaar based payments (ABP) are explained to the MGNREGA beneficiaries.
- C. It may also be explained that the Aadhaar numbers of the beneficiaries will be used for seeding in their bank account, in case they are not mapped to NPCI mapper. For accounts already mapped on NPCI mapper, it will automatically be converted to ABPS.

4. The stipulation at 3 (A), (B) and (C) will have effect from 15th October 2015. A provision has been enabled in NREGASoft to capture the consent of the workers, details of which are enclosed for information.

5. The States/UTs are requested to intimate the compliance of the above to this Ministry latest by 25th January, 2016

STEPS:

In the 'Add UID No. (Aadhaar No./Enrollment No)' form (available in GP & PO Data Entry logins), After selecting **Panchayat** → **Village** → **Registration No.**, the form would display the list of applicants for whom Aadhaar number is not yet updated in NREGASoft.

- To update Aadhaar number (UID)/Enrolment number (EID) of an applicant, it is mandatory to give the consent of beneficiary by clicking the 'Consent by Beneficiary' check box (Please refer the 'Note' given in the bottom of the form related to 'Consent by Beneficiary'). Once check box is ticked, then only the text boxes would be enabled to enter.
- 'Applicant name as per Aadhaar Card' should be entered in 'English' only.
